**2009 - 2010 PLUS – Student Eligibility Requirements**

  - I will be working on masters or doctorate program in 2009-2010.
  - I am married as of today.
  - I have children for whom I provide more than half of their support.
  - I have dependents (other than a child or spouse) who live with me and for whom I provide more than half of their support.
  - Both of my parents are deceased, or I was a ward/dependent of the court up until the age of 18.
  - I am a veteran of the U.S. Armed Forces.
  - I am/was an emancipated minor as determined by a court in my state of legal residence.
  - I am/was in legal guardianship as determined by a court in my state of legal residence.
  - As of July 1, 2008 or later, my high school district homeless liaison determined that I was an unaccompanied youth who was homeless.
  - As of July 1, 2008 or later, the director of an emergency shelter or transitional housing program funded by the U.S. Department of Housing and Urban Development determined that I was an unaccompanied youth who was homeless.
  - As of July 1, 2008 or later, the director of a runaway or homeless youth basic center or transitional living program determined that I was an unaccompanied youth who was homeless or self-supporting and at risk of being homeless.
